2012 Board of Directors

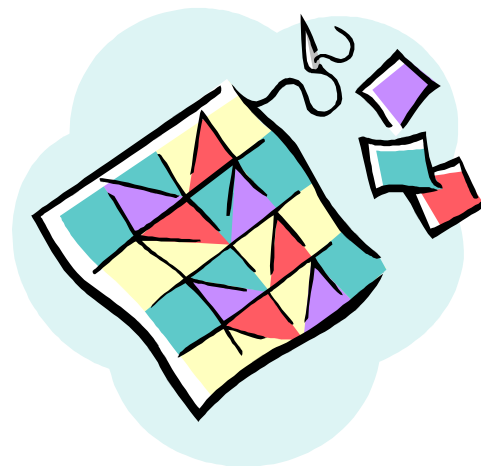

Meeting Minutes

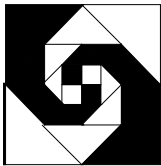

Donna Feagin, our sister quilter, passed Saturday after having struggled with pancreatic cancer for the past six months. Smitty invited us in a moment of silence to honor Donna. The family will notify us once they know the service information. Ruth Jorgensen had a hip replacement and a card went around for all to sign. The Opportunity Quilt, SLO Aloha, is finished and on display. Packets with tickets and instructions for selling tickets for the quilt were handed to members present. Those that didn't get their packets at the meeting will be sent their packets. Suzanne McDermott volunteered to make a label for the quilt. Seven Sisters Quilt Show: If you'd like your quilt to be judged at the show, applications are available. Tickets were sold by Susan Chandler and Suzanne McDermott for opportunity quilt to benefit Congregational Church of Christ's Outreach program. Block of the Month - Kathy Clarke. Quite a few members with finished tops. Christmas Stockings - Paula Jaster thanked members for making 175 stockings; Signe James made 30, Ruth Meador and Judy Fry together made 106. Ruth and Judy were each presented a \$10.00 gift certificate for Betty's for their combined efforts. Executive Board 2012 - Jill Sabol presented proposed board: President-Susan Smitty Price, Vice President-Jody Nelson, Secretary-Loisann Cass, Treasurer-Gail Simmons and asked

for nominations from floor. Since there were none, Paula Jaster/Christine LaBuda moved that we accept proposed slate of officers. Motioned carried unanimously. Upcoming Programs - Suzanne Heitzmann - January will be a take-away project. March will be held on Friday rather than the normal 2nd Monday to accommodate the Saturday workshop. We're going to give this a try for 2012. The 30th Anniversary pins are for sale for \$5 from Margaret Wheeler. Community Quilts - Signe James and five members had a work day and showed string quilts they made. There will be another sew day in January or February. Signe talked about the label used on all community quilts that has been used by SLO Guild for a long time and how the whole community quilt project started with a baggie of scraps Pam Munns had given to Signe, from which she made quilts. Later, Pam Munns told about having been president and wanting to encourage and involve as many people as possible in the community quilts project. Show & Tell. Program: Vicki Bookless introduced our speaker, Pam Munns. Pam is a retired Highway Patrol Officer who collects antique quilts, has appeared on Alex Anderson show, and is a character in one of Earlene Fowler's book. She is a prolific quilter, starting in 1980 inspired by Alex Anderson and her quilting friends. Influences in her life have been from her family, career in law enforcement, and living in Pakistan for many years. She has been teaching for five years and showed quilts from her 30 year journey.
